A Regular meeting of the Harmony City Council was called to order by Mayor Steve Donney at 7:00 PM. Present were Mayor Donney, Councilpersons Kyle Morem, Steve Sagen, Debbie Swenson, and Lynn Mensink; Attorney Richard Nethercut, Administrator Jerome Illg, Chris Johnson, Melissa VanderPlas, Hannah Wingert, Tony Severson, Greg Skauge, Jeff Holmquist, Jay Nieson.

OPEN FORUM: No one appeared.

CONSENT AGENDA:

Motion by Mensink and seconded by Swenson to approve the Consent Agenda which consisted of the Minutes to the November 15, 2016 Council Meeting, the Claims, the Administrator's Report, the Financial Report, Cash in CD #43603 to the General Fund, approving an internal bank transfer for state fire aid \$17,327.15 and city contribution of \$7,500 to fire relief association. All present voting yes. Motion carried.

ODD/EVEN PARKING:

Administrator Illg mentioned David Larson requested placement on the agenda to discuss odd/even parking given that he only has parking available on one side of 1st Ave SW south of 5th St SW where he lives. He did not attend the council meeting. The council reviewed the ordinance and did not change the ordinance.

GARBAGE/RECYCLING RFP:

The council reviewed the Garbage and Recycling RFP results. Discussion occurred on the various options regarding cart service versus the current bag service. Discussion occurred regarding the prices being submitted for residential service and commercial service being tied together. The council felt that they should not be tied together and viewed independently. Motion by Morem and seconded by Sagen to approve 5 year contract (starting April 2017) with WasteManagement for Residential Service for bags and bins (same as current contract). All present voting yes. Motion carried. Motion by Donney, seconded by Swenson to approve WasteManagement and S&S Sanitation to approve for commercial service. All present voting yes. Motion carried.

BUILDING AND MAINTENANCE REPORT:

Administrator Illg mentioned that Terry's pickup currently has a number of maintenance items. State bids were gathered. The council reviewed 4 different bids with options. Motion by Donney, seconded by Sagen to approve state bid of Chev Double Cab with 6' box of \$26,635.55 with funds from capital equipment fund and sell current truck "as-is" on seal bid. All present voting yes. Motion carried. Chris Johnson discussed the dechlorination equipment that was installed. He is working with Todd Arlander from Stantec on the adjustments with the equipment.

EDA REPORT:

Reviewing the Logo's from the Logo Contest. Chamber Report with recent activities.

Motion by Morem, seconded by Mensink to approve revolving loan of \$25,000 at 3.5% for 7 years for a purchase of existing equipment and inventory from a small gas engine business with building renovations to a vacant building. All present voting yes. Motion carried.

PARK BOARD:

No report, since did not meet in December.

LIBRARY BOARD:

They had approximately 150 people for their 100 year anniversary at the library.

They are continuing to look at options for the patio at the library.

They discuss the value that a library has to the community based upon the circulation.

ARTS BOARD:

Discuss Wilt/Clodfelter concert.

Donated \$1,400 to Monster Bash project.

There is a Christmas and Canvas Painting project on December 16th as a fundraiser for Monster Bash.

They sponsored a Musical Artist in Residence for the school project.

BUDGET:

Administrator Illg presented the 2017 budget.

RESOLUTION 16-06 WAS PRESENTED: A RESOLUTION CERTIFYING THE PROPOSED PROPERTY TAX LEVY TO THE COUNTY AUDITOR FOR 2016 TAXES PAYABLE IN 2017. Motion to adopt the Resolution by Donney and seconded by Swenson with the general fund amount \$177,400 and total at \$590,000 for all levied funds.

Voting for the Resolution was: Swenson, Morem, Mensink, Sagen and Donney

Voting against the Resolution was: No One

Abstained from Voting was: No One Absent from Voting was: No One

The motion passed and resolution was adopted.

Administrator Illg mentioned that based upon the presented expenditure budget, that with the approved levy that we will be funding expenditures from general fund reserves. He cautioned doing that because it can be harmful in the future.

Discussion occurred regarding trimming boulevard trees if they are obstructing snow removal and street equipment.

Volunteer ambulance and firemen were thanked for their service.

Upon no further business, Mayor Donney adjourned the meeting.

HARMONY Historical Signage Project

The Harmony Area Historical Society (HAHS) with the Harmony Area Community Foundation (HACF) is working on a project to develop & install historical signage in the downtown area showcasing Harmony's history and historical sites.

This historical project will support Harmony's vision of community vitality by providing community pride for our residents and also will provide another tourist activity. The plans include development of a walking tour and brochure.

This project was stimulated by an opportunity for a **Southern Minnesota Initiative Foundation (SMIF)** Community Collaboration Grant (\$10,000); a one year opportunity celebrating their 30 year anniversary. Part of the grant application is that this project be a "collaborative" effort with other community organizations. HAHS will be working with the City, local organizations and businesses to accomplish this goal.

The project will be carried out predominately by **HAHS** members with assistance as necessary from **HACF** and various community members. Presently, **HAHS** is accumulating historical data to be used for signage and has contacted various signage companies for quotes. A great resource for this project is the "Let's Have Harmony" book written for Harmony's centennial in 1996. Both **HAHS** and the **HACF** members have been involved in decision-making process and have contacted various community members for their possible involvement as well.

The time line for the grant/project include:

- application deadline January 15, 2017
- grant awards by February 15, 2017
- project completion & reports by September 1, 2017

The current plan is defined with up to 6 - 2' x 3' sloped signs at Main Avenue locations and 1-2 larger signs at the main entrance to the Visitor Center. The smaller signs would showcase the history of the town as visualized from that specific location. The larger signs would include general history of Harmony and highlight specific areas of interest. The design is based on historical signage currently installed in Decorah, IA. The final number of signs and exact locations have not been finalized. Ideally, the Maine Avenue signs would be mounted on the sidewalk areas next to the curbs between the Hwy 52 intersection and just south of Center Street; some examples of the signage are shown on the attached page.

The size of this project is somewhat limited by the current grant funds and project completion date requirement. Initial estimates indicate the cost could easily exceed the proposed **SMIF** grant amount and may require some additional funding sources. Other signage and topics have been discussed (schools, churches, businesses, etc.) but would need to be defined and additional funding to support.



This Agreement is between the State of Minnesota, acting through its Commissioner of Transportation ("State") and the City of Harmony acting through its City Council ("City").

Recitals

- 1. The State will perform bituminous mill and overlay, ADA improvements, and culvert construction and other associated construction upon, along and adjacent to Trunk Highway No. 139 from Trunk Highway No. 52 in Harmony to the Iowa/Minnesota State line according to State-prepared plans, specifications and special provisions designated by the State as State Project No. 2316-16 (T.H. 139=079) ("Project"); and
- 2. The City has requested the State include in its Project pedestrian crosswalk construction; and
- 3. The City wishes to participate in the costs of the pedestrian crosswalk construction and associated construction engineering; and
- 4. The State has identified several City owned utilities in State Right-of-Way that will need to be adjusted and or relocated as part of said Project. The City has agreed to participate in the costs of these utility adjustments and associated construction engineering; and
- 5. Minnesota Statutes § 161.45, subdivision 2, allows for City-owned utility relocation to be included in a State construction contract, and payment by the City for such relocation according to applicable statutes and rules for utilities on trunk highways; and
- 6. Minnesota Statutes § 161.20, subdivision 2 authorizes the Commissioner of Transportation to make arrangements with and cooperate with any governmental authority for the purposes of constructing, maintaining and improving the trunk highway system.

Agreement

1. Term of Agreement; Survival of Terms; Plans; Incorporation of Exhibits

- **1.1.** *Effective Date.* This Agreement will be effective on the date the State obtains all signatures required by Minnesota Statutes § 16C.05, subdivision 2.
- 1.2. Expiration Date. This Agreement will expire when all obligations have been satisfactorily fulfilled.
- **1.3.** Survival of Terms. All clauses which impose obligations continuing in their nature and which must survive in order to give effect to their meaning will survive the expiration or termination of this Agreement, including, without limitation, the following clauses: 3. Maintenance by the City; 8. Liability; Worker Compensation Claims; 10. State Audits; 11. Government Data Practices; 12. Governing Law; Jurisdiction; Venue; and 14. Force Majeure.
- **1.4.** *Plans, Specifications, Special Provisions.* Plans, specifications and special provisions designated by the State as State Project No. 2316-16 (T.H. 139=079) are on file in the office of the Commissioner of Transportation at St. Paul, Minnesota, and incorporated into this Agreement by reference ("Project Plans").

1.5. *Exhibits.* Preliminary Schedule "I" is on file in the office of the City Administrator and incorporated into this Agreement by reference.

2. Construction by the State

2.1. Contract Award. The State will advertise for bids and award a construction contract to the lowest responsible bidder according to the Project Plans.

2.2. Direction, Supervision and Inspection of Construction.

- **A.** Supervision and Inspection by the State. The State will direct and supervise all construction activities performed under the construction contract, and perform all construction engineering and inspection functions in connection with the contract construction. All contract construction will be performed according to the Project Plans.
- **B.** *Inspection by the City.* The City participation construction covered under this Agreement will be open to inspection by the City. If the City believes the City participation construction covered under this Agreement has not been properly performed or that the construction is defective, the City will inform the State District Engineer's authorized representative in writing of those defects. Any recommendations made by the City are not binding on the State. The State will have the exclusive right to determine whether the State's contractor has satisfactorily performed the City participation construction covered under this Agreement.

2.3. Plan Changes, Additional Construction, Etc.

- A. The State will make changes in the Project Plans and contract construction, which may include the City participation construction covered under this Agreement, and will enter into any necessary addenda, change orders and supplemental agreements with the State's contractor that are necessary to cause the contract construction to be performed and completed in a satisfactory manner. The State District Engineer's authorized representative will inform the appropriate City official of any proposed addenda, change orders and supplemental agreements to the construction contract that will affect the City participation construction covered under this Agreement.
- **B.** The City may request additional work or changes to the work in the plans as part of the construction contract. Such request will be made by an exchange of letter(s) with the State. If the State determines that the requested additional work or plan changes are necessary or desirable and can be accommodated without undue disruption to the project, the State will cause the additional work or plan changes to be made.
- **2.4.** Satisfactory Completion of Contract. The State will perform all other acts and functions necessary to cause the construction contract to be completed in a satisfactory manner.
- **2.5.** Replacement of Castings. Adjustments to certain City-owned facilities, including but not limited to, valve boxes and frame and ring castings, may be performed by the State's contractor under the construction contract. The City will furnish the contractor with new units and/or parts for those in place City-owned facilities when replacements are required and not covered by a contract pay item, without cost or expense to the State or the contractor, except for replacement of units and/or parts broken or damaged by the contractor.

3. Maintenance by the City.

Upon completion of the project, the City will provide the following without cost or expense to the State:

3.1. Storm Sewers. Routine maintenance of any storm sewer facilities construction. Routine maintenance includes, but is not limited to, removal of sediment, debris, vegetation and ice from grates and catch basins and any other maintenance activities necessary to preserve the facilities and to prevent conditions such as flooding, erosion, or sedimentation, this also includes informing the District Maintenance Engineer of any needed repairs.

3.2. *Municipal Utilities.* Maintenance of any municipal-owned utilities construction, without cost or expense to the State.

- **3.3.** *Sidewalk and Pedestrian Crosswalks.* Maintenance of any sidewalk construction, including stamped and colored concrete sidewalk (if any) and pedestrian ramps. Maintenance includes, but is not limited to, snow, ice and debris removal, patching, crack repair, panel replacement, cross street pedestrian crosswalk markings, vegetation control of boulevards (if any) and any other maintenance activities necessary to perpetuate the sidewalks in a safe, useable, and aesthetically acceptable condition. The City will be responsible for all maintenance and striping of the crosswalks located at the north line of Center Street and the south line of 1st Street NW and 1st Street NE.
- **3.4.** Additional Drainage. Neither party to this Agreement will drain any additional drainage volume into the storm sewer facilities constructed under the construction contract that was not included in the drainage for which the storm sewer facilities were designed, without first obtaining written permission to do so from the other party. The drainage areas served by the storm sewer facilities constructed under the construction contract are shown in a drainage area map, EXHIBIT "Drainage Area", which is on file in the office of the State's District Hydraulics Engineer at Rochester and is incorporated into this Agreement by reference.

4. Basis of City Cost

- **4.1. SCHEDULE "I".** The Preliminary Schedule "I" includes all anticipated City participation construction items and the construction engineering cost share covered under this Agreement, and is based on engineer's estimated unit prices.
- **4.2.** *City Participation Construction.* The City will participate in the following at the percentages indicated. The construction includes the City's proportionate share of item costs for mobilization, field office, field laboratory and traffic control.
 - **A.** 100 Percent will be the City's rate of cost participation in all of the crosswalk striping and utility adjustment construction. The construction includes, but is not limited to, those construction items tabulated on Sheet No. 2 of the Preliminary Schedule "I".
- **4.3.** Construction Engineering Costs. The City will pay a construction engineering charge equal to 8 percent of the total City participation construction covered under this Agreement.
- **4.4.** *Plan Changes, Additional Construction, Etc.* The City will share in the costs of construction contract addenda, change orders and supplemental agreements that are necessary to complete the City participation construction covered under this Agreement, including any City requested additional work and plan changes.
 - The State reserves the right to invoice the City for the cost of any additional City requested work and plan changes, construction contract addenda, change orders and supplemental agreements, and associated construction engineering before the completion of the contract construction.
- **4.5.** Liquidated Damages. All liquidated damages assessed the State's contractor in connection with the construction contract will result in a credit shared by each party in the same proportion as their total construction cost share covered under this Agreement is to the total contract construction cost before any deduction for liquidated damages.

5. City Cost and Payment by the City

5.1. City Cost. \$16,787.52 is the City's estimated share of the costs of the contract construction and the 8 percent construction engineering cost share as shown in the Preliminary Schedule "I". The Preliminary Schedule "I" was prepared using estimated quantities and unit prices, and may include any credits or lump sum costs. Upon award of the construction contract, the State will prepare a Revised Schedule "I" based on construction contract unit prices, which will replace and supersede the Preliminary Schedule "I" as part of this agreement.

- **5.2.** Conditions of Payment. The City will pay the State the City's total estimated construction and construction engineering cost share, as shown in the Revised Schedule "I", after the following conditions and dates have been met:
 - A. Execution of this Agreement and transmittal to the City, including a copy of the Revised Schedule "I".
 - **B.** The City's receipt of a written request from the State for the advancement of funds on or after July, 1 2017.
- **5.3.** Acceptance of the City's Cost and Completed Construction. The computation by the State of the amount due from the City will be final, binding and conclusive. Acceptance by the State of the completed contract construction will be final, binding and conclusive upon the City as to the satisfactory completion of the contract construction.
- **5.4.** *Final Payment by the City.* Upon completion of all contract construction and upon computation of the final amount due the State's contractor, the State will prepare a Final Schedule "I" and submit a copy to the City. The Final Schedule "I" will be based on final quantities, and include all City participation construction items and the construction engineering cost share covered under this Agreement. If the final cost of the City participation construction exceeds the amount of funds advanced by the City, the City will pay the difference to the State without interest. If the final cost of the City participation construction is less than the amount of funds advanced by the City, the State will refund the difference to the City without interest.

The State and the City waive claims for any payments or refunds less than \$5.00 according to Minnesota Statutes § 15.415.

6. Authorized Representatives

Each party's Authorized Representative is responsible for administering this Agreement and is authorized to give and receive any notice or demand required or permitted by this Agreement.

7. Assignment; Amendments; Waiver; Contract Complete

- **7.1.** Assignment. Neither party may assign or transfer any rights or obligations under this Agreement without the prior consent of the other party and a written assignment agreement, executed and approved by the same parties who executed and approved this Agreement, or their successors in office.
- **7.2.** Amendments. Any amendment to this Agreement must be in writing and will not be effective until it has been executed and approved by the same parties who executed and approved the original Agreement, or their successors in office.
- **7.3.** *Waiver.* If a party fails to enforce any provision of this Agreement, that failure does not waive the provision or the party's right to subsequently enforce it.

7.4. Contract Complete. This Agreement contains all prior negotiations and agreements between the State and the City. No other understanding regarding this Agreement, whether written or oral, may be used to bind either party.

8. Liability; Worker Compensation Claims

- **8.1.** Each party is responsible for its own acts, omissions and the results thereof to the extent authorized by law and will not be responsible for the acts and omissions of others and the results thereof. Minnesota Statutes § 3.736 and other applicable law govern liability of the State. Minnesota Statutes Chapter 466 and other applicable law govern liability of the City.
- **8.2.** Each party is responsible for its own employees for any claims arising under the Workers Compensation Act.

9. Nondiscrimination

Provisions of Minnesota Statutes § 181.59 and of any applicable law relating to civil rights and discrimination are considered part of this Agreement.

10. State Audits

Under Minnesota Statutes § 16C.05, subdivision 5, the City's books, records, documents, and accounting procedures and practices relevant to this Agreement are subject to examination by the State and the State Auditor or Legislative Auditor, as appropriate, for a minimum of six years from the end of this Agreement.

11. Government Data Practices

The City and State must comply with the Minnesota Government Data Practices Act, Minnesota Statutes Chapter 13, as it applies to all data provided under this Agreement, and as it applies to all data created, collected, received, stored, used, maintained, or disseminated by the City under this Agreement. The civil remedies of Minnesota Statutes §13.08 apply to the release of the data referred to in this clause by either the City or the State.

12. Governing Law; Jurisdiction; Venue

Minnesota law governs the validity, interpretation and enforcement of this Agreement. Venue for all legal proceedings arising out of this Agreement, or its breach, must be in the appropriate state or federal court with competent jurisdiction in Ramsey County, Minnesota.

13. Termination; Suspension

- 13.1. By Mutual Agreement. This Agreement may be terminated by mutual agreement of the parties.
- **13.2.** *Termination for Insufficient Funding.* The State may immediately terminate this Agreement if it does not obtain funding from the Minnesota Legislature, or other funding source; or if funding cannot be continued at a level sufficient to allow for the performance of contract construction under the Project. Termination must be by written or fax notice to the City.
- **13.3.** *Suspension.* In the event of a total or partial government shutdown, the State may suspend this Agreement and all work, activities and performance of work authorized through this Agreement.

14. Force Majeure

Neither party will be responsible to the other for a failure to perform under this Agreement (or a delay in performance), if such failure or delay is due to a force majeure event. A force majeure event is an event beyond a party's reasonable control, including but not limited to, unusually severe weather, fire, floods, other acts of God, labor disputes, acts of war or terrorism, or public health emergencies.



RE: Audit Fees

Current:

Our current auditors, Abdo, Eick, and Meyers submitted a 3 year proposal for audits (2014-2016). The fees in that proposal were as follows:

2014	\$16,255
2015	\$16,605
2016	\$17,230

I challenged the auditors if there was a way to reduce the audit fee, since I have historically done a thorough job of preparing the audit that makes it easy for them.

Proposal:

They have proposed the following for consideration:

Reduce the audit fee for 2016 by \$1,500 to \$15,730 with a 3 year contract (2017-2019). The 2017 audit fee would be the same as 2016, and 2018-2019 would be a 2.5% increase. Thus the fees would be as follows:

2016	\$15,730
New Contract	
2017	\$15,730
2018	\$16,123
2019	\$16,526

This new proposal would be contingent upon having everything thoroughly prepared similar to what I have done in the past, which should not be a problem.

The other option would be to do an RFP for 2017-2019 services, and not save the \$1,500 (for 2016), and not be assured of the audit fee (for 2017-2019).
